Hurst also have particular experience of tiling for both leisure and competition **swimming pools** to meet ASA or FINA accreditation requirements.



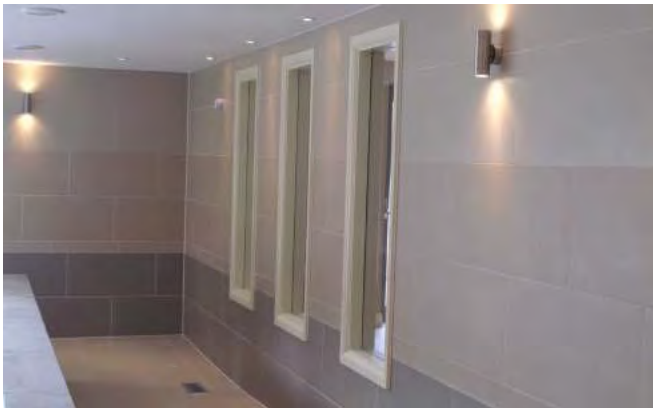

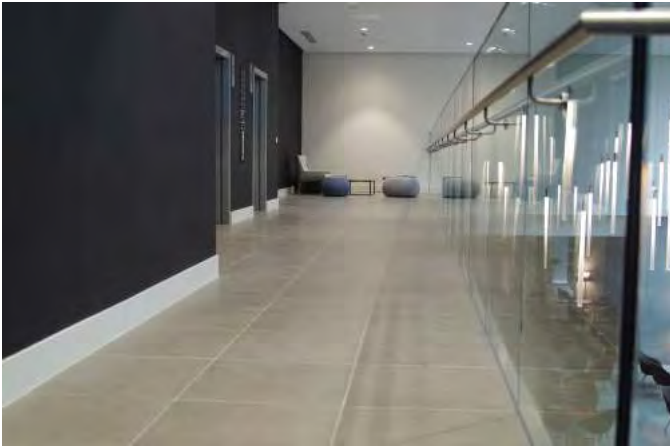
Merlwood is a group of 55 self-catering holiday cottages and apartments in Grange-Over-Sands set in a beautifully restored Victorian mansion.

Hurst delivered the tiling requirements for the **Merlwood Leisure Centre** which included:

- Tiling of indoor pool.
- Wall tiling.
- Tiling of changing rooms.
- Tiling of toilets and showers.

Hurst delivered the tiling requirements for the **Pullman Hotel** situated on the newly developed Liverpool Waterfront. The project included floor tiling to the following areas:

- **Hotel reception area.**

This included the install of a unique marble especially quarried and imported from Majorca for the project, the marble was polished on site to a high lustre.

Hurst completed the tiling requirements for a new **World Duty Free Collection** store at London Luton Airport. This involved the laying of new 'Mirrorchip' Gulfstone Quartz ceramic tile flooring to the main store sales floor in two colours. The area covered was 255 m². Hurst also completed the tiling for the World Duty Free stores at Liverpool and Newcastle airports.

Hurst completed the tiling requirements for the **Victoria Secrets** store at Luton airport. The distinctive black and white diamond pattern for the sales floor is a striking feature.

The success of the **Hurst Occupational Health and Safety Management System** is dependent on it's understanding and acceptance by all employees, this is achieved through the on-going provision of education and training.

Hurst maintains a **Training Record Matrix** for all employees (which can be provided on request) and safety related training is provided by commercial providers e.g. CITB, IPAF & PASMA. All Project Managers, Senior Managers and Directors are required to have attended the IOSH Managing Safely course, Site Managers must hold a SMSTS certificate and Site Operatives are required to hold a current CSCS card. Hurst undertakes an annual review of health and safety training and an annual training programme is produced for all levels of staff.

Further to this Hurst is committed to the professional development of all employees and has an established **Apprentice Scheme** employing a number of apprentices on a full time basis throughout their 3 years at college.

Hurst conducts business in a sustainable way to reduce our impact on the environment overall. We are able to deliver projects with timber supplied only from sustainable sources and are fully conversant with the requirements of the current EU timber regulations.

Having invested in a Talbott Biomass Boiler, the Hurst Joinery manufacturing facility can now recycle or reuse timber by-products to produce heat for the factory environment. This in turn reduces the amount of waste that is sent to landfill.

Our Environmental Aims:

- **To ensure compliance with all relevant environmental legislation, regulations and standards.**
- **To ensure all staff understand their impact upon the environment and are aware of their obligations and responsibilities.**
- **The reduction of the use of natural resources.**
- **The reduction and effective management of waste.**

- **The minimisation of carbon emissions during construction works.**
- **The re-cycling of paper, timber and metals.**

The Hurst **Occupational Health and Safety Management System** enables us to pro-actively manage health and safety across all our business operations and ensures that we can deliver the highest health and safety standards on all projects. The system is reviewed annually by our Directors and external Health and Safety Advisor in order to take into consideration new legislation and best practice from other industry sectors.

The Safety Management Procedures which make up the system have been developed and must be complied with by the company management and employees. This includes procedures which ensure Hurst can meet the responsibilities of the CDM Regulations 2015.

It also includes procedures for:

- **Issue and use of PPE.**
- **Incident Reporting.**
- **Risk Assessments.**
- **COSHH Assessment.**
- **Safety Method Statements.**
- **Plant and Equipment.**
- **Manual Handling.**
- **Construction Phase Plans.**
- **Waste Management.**

Hurst works closely with an external **Health and Safety Advisor** whose main responsibilities include:

- Producing a monthly Health and Safety Report.
- Undertaking Accident and Incident Investigations and producing reports.
- Performing regular site inspections and producing reports.
- Giving general advice and support on all Health and Safety issues.
- Keeping Hurst up to date on current legislation and best working methods.
