The fit out included the following mechanical and electrical elements:

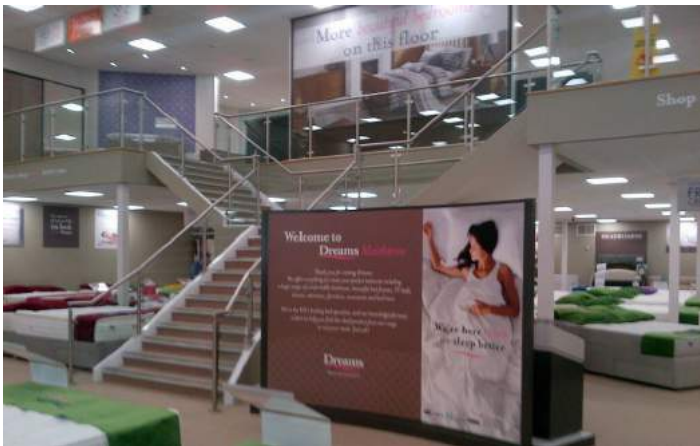

The success of the **Hurst Occupational Health and Safety Management System** is dependent on it's understanding and acceptance by all employees, this is achieved through the on-going provision of education and training.

Hurst maintains a **Training Record Matrix** for all employees (which can be provided on request) and safety related training is provided by commercial providers e.g. CITB, IPAF & PASMA. All Project Managers, Senior Managers and Directors are required to have attended the IOSH Managing Safely course, Site Managers must hold a SMSTS certificate and Site Operatives are required to hold a current CSCS card. Hurst undertakes an annual review of health and safety training and an annual training programme is produced for all levels of staff.

Further to this Hurst is committed to the professional development of all employees and has an established **Apprentice Scheme** employing a number of apprentices on a full time basis throughout their 3 years at college.

Hurst conducts business in a sustainable way to reduce our impact on the environment overall. We are able to deliver projects with timber supplied only from sustainable sources and are fully conversant with the requirements of the current EU timber regulations.

Having invested in a Talbott Biomass Boiler, the Hurst Joinery manufacturing facility can now recycle or reuse timber by-products to produce heat for the factory environment. This in turn reduces the amount of waste that is sent to landfill.

The Safety Management Procedures which make up the system have been developed and must be complied with by the company management and employees. This includes procedures which ensure Hurst can meet the responsibilities of the CDM Regulations 2015.

It also includes procedures for:

- **Incident Reporting.**
- **Risk Assessments.**
- **COSHH Assessment.**
- **Safety Method Statements.**
- **Plant and Equipment.**
- **Manual Handling.**
- **Construction Phase Plans.**
- **Waste Management.**

Hurst works closely with an external **Health and Safety Advisor** whose main responsibilities include:

- Producing a monthly Health and Safety Report.
- Undertaking Accident and Incident Investigations and producing reports.
- Performing regular site inspections and producing reports.
- Giving general advice and support on all Health and Safety issues.
- Keeping Hurst up to date on current legislation and best working methods.
