The prime purpose of fire doors is to save lives and stop the progress of fire in support of both escaping occupants and fire-fighting activities. They are an integral part of a building's passive fire protection system and an essential requirement for the vast majority of premises including residential, public buildings, offices and factories.

The main functions of fire doors are:

- To allow egress from a space and to close once released
- Protect escape routes from the effects of fire (smoke, gases and flames)
- Potentially limit the amount of oxygen available and slow the growth of a fire

Third party certification

Third party certification provides independent reassurance to specifiers and purchasers that products are manufactured and/ or installed to a consistent high quality, through continuous audit procedures and regular sample testing.



Fire Safety Legislation

Since the Regulatory Reform (Fire Safety) Order came into force in 2005, the responsibility for fire safety sits with building owners, managers, landlords, headteachers and anyone else who has control of the premises. They are required to appoint the role of a 'Responsible Person' to carry out the necessary duties in implementing a Fire Safety Strategy.

Role of the 'Responsible Person'

The Responsible Person must ensure that there is a fire safety strategy in place. This includes carrying out an annual fire risk assessment of the building and putting in place appropriate safety measures and procedures to be acted upon in the event of an emergency.



Fire Door Testing

Fire rated doors play a critical role in the safety of a building in the event of a fire, and therefore need to be able to demonstrate proof of compliance with fire safety legislation.

It is important to note that the compliance of a fire rated doorset is reliant on all the individual components matching the certifed furnace tested design. This includes all ironmongery and seals alongside the door frame and door leaves.

In addition, the correct installation of the doorset is critical to the door's performance in the event of a fire.

Third party accredited installers are able to provide proof of the quality of their installation work.


